## **Veteran's Discharge Upgrade Review Clinic**

**Info:** Non-profit organization that provides legal assistance to low income individuals with legal needs in Dearborn, Fayette, Franklin, Jefferson, Ohio, Ripley, Switzerland, Union, and Wayne Counties. In order to qualify, an application must be completed to obtain household income and information. Applicants must have a household income no greater than 125% of the federal poverty quidelines.

**Areas of Practice:** Attorneys can provide legal advice/consultation/referral in the areas of family law, consumer law, housing, wills, elder law issues. Cannot accept criminal cases or any cases that generate a fee.

**Info:** Legal Aid of the Bluegrass serves low-income families with children, the elderly, Veterans and people needing access to healthcare. Cannot advise or help resolve criminal charges/matters/cases. Individuals must have a before tax income of 125% or below the federal poverty guidelines in order to quality for services, yet may be able to receive a waiver if income is within 125%-200% of the federal poverty guidelines.

**Areas of Practice:** Provides advice/consultation/referral on bankruptcy, domestic/interpersonal violence; eviction, foreclosure and other housing issues; criminal record expungement, public/health benefits, will, living will and power of attorney.

**Info:** Callers can expect to work with a NKU law student (supervised by a licensed attorney) or an attorney to review their request and walk them through the application process to the Discharge Review Board (DRB) of their respective branch of service, if appropriate. Services are NOT limited to Kentucky residents. Any Veteran from anywhere can call to inquire. Preferred that Veteran at minimum have their DD-214 available.
